WHAT WE DO AS THE SALVATION ARMY TO FIGHT HUMAN TRAFFICKING IN THE UNITED STATES

What do we do as The Salvation Army to fight Human Trafficking in the United States?

The Salvation Army has historically been on the frontlines fighting human trafficking since the time of William Booth in London, England—advocating to raise the legal age of consent. We have come a long way, but the battle is far from over ...

The Salvation Army is opposed to the corrupt abuse of power against other human beings that

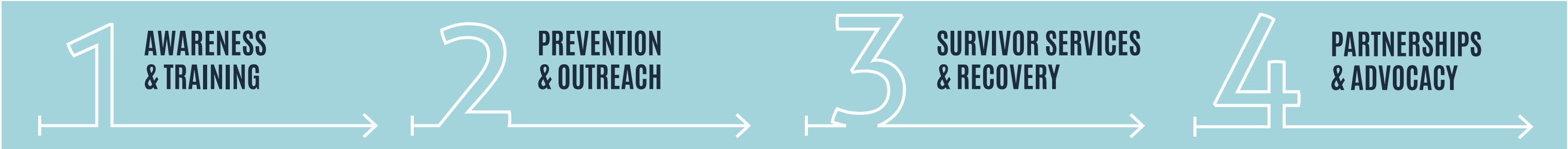
is inherent in trafficking for personal economic gain. We therefore have the responsibility, both individually and collectively, to work for the liberation of those who have been enslaved in this manner, and to establish the legal and social mechanism by which human trafficking can be stopped.

HIGHLIGHTS ACROSS THE UNITED STATES OF AMERICA

- ▶ 26 Anti-Trafficking programs across the nation
- ▶ 71 staff members holding anti-trafficking positions
- ▶ Each Territory has a Territorial Anti-Trafficking position
- ▶ OVC-funded programs across the nation
- ▶ Drop-in centers serving survivors
- ▶ Provide expert training and awareness across the territory to those in various disciplinary backgrounds such as law enforcement, social services, health care, business, faith-based communities and educational institutions
- ▶ North American Anti-Trafficking Committee with representatives from each territory is working to strengthen our anti-trafficking initiatives

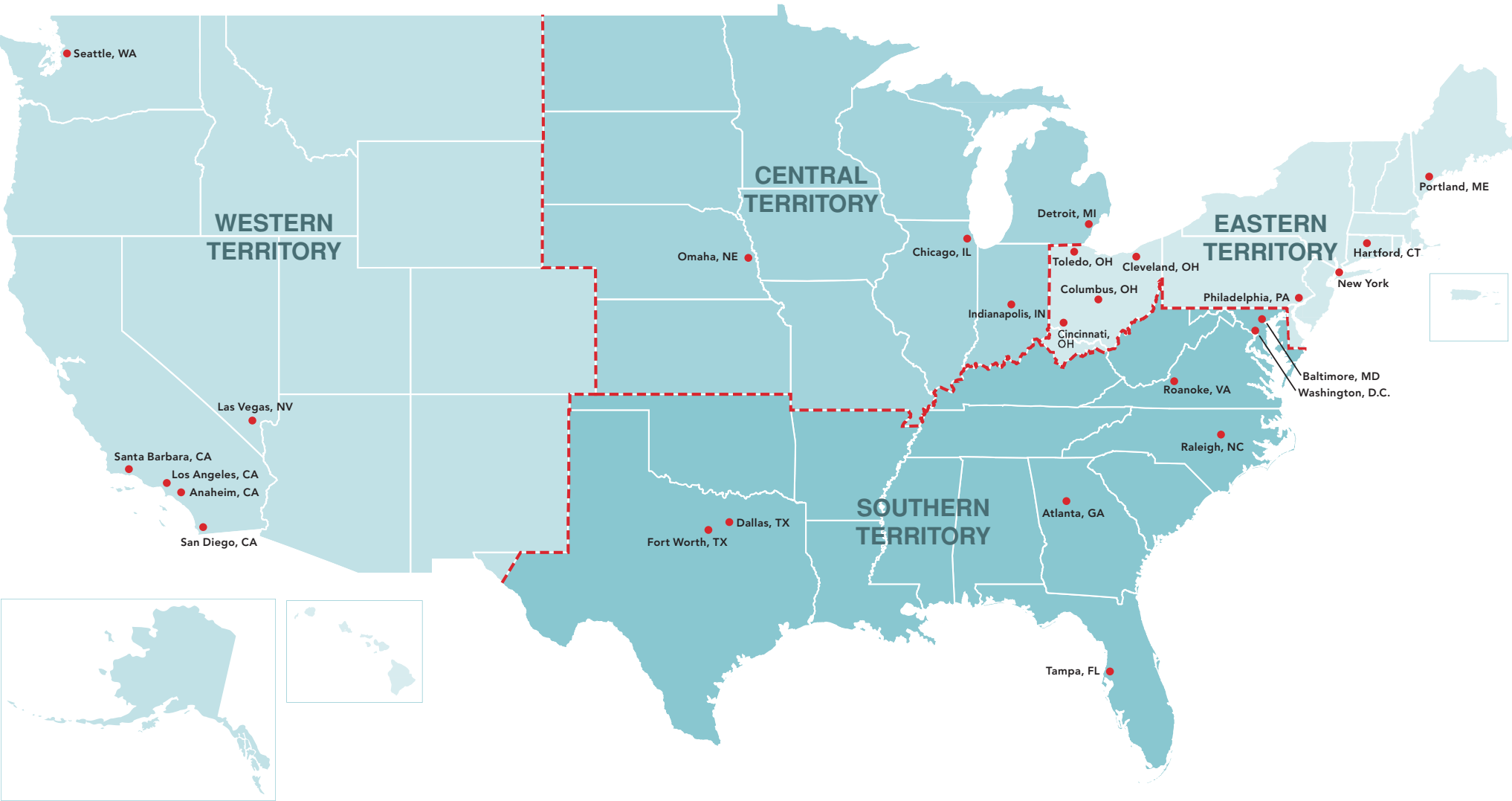

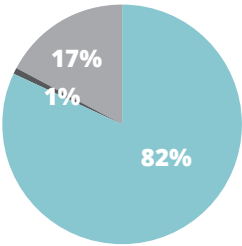

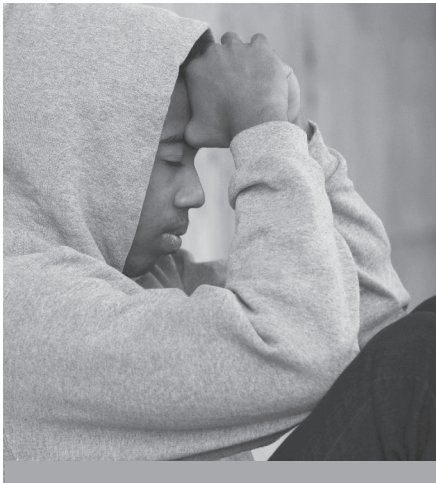
Survivor Services & Recovery Impact

We cannot do this work alone. We must form strong collaborations in the fight against human trafficking.

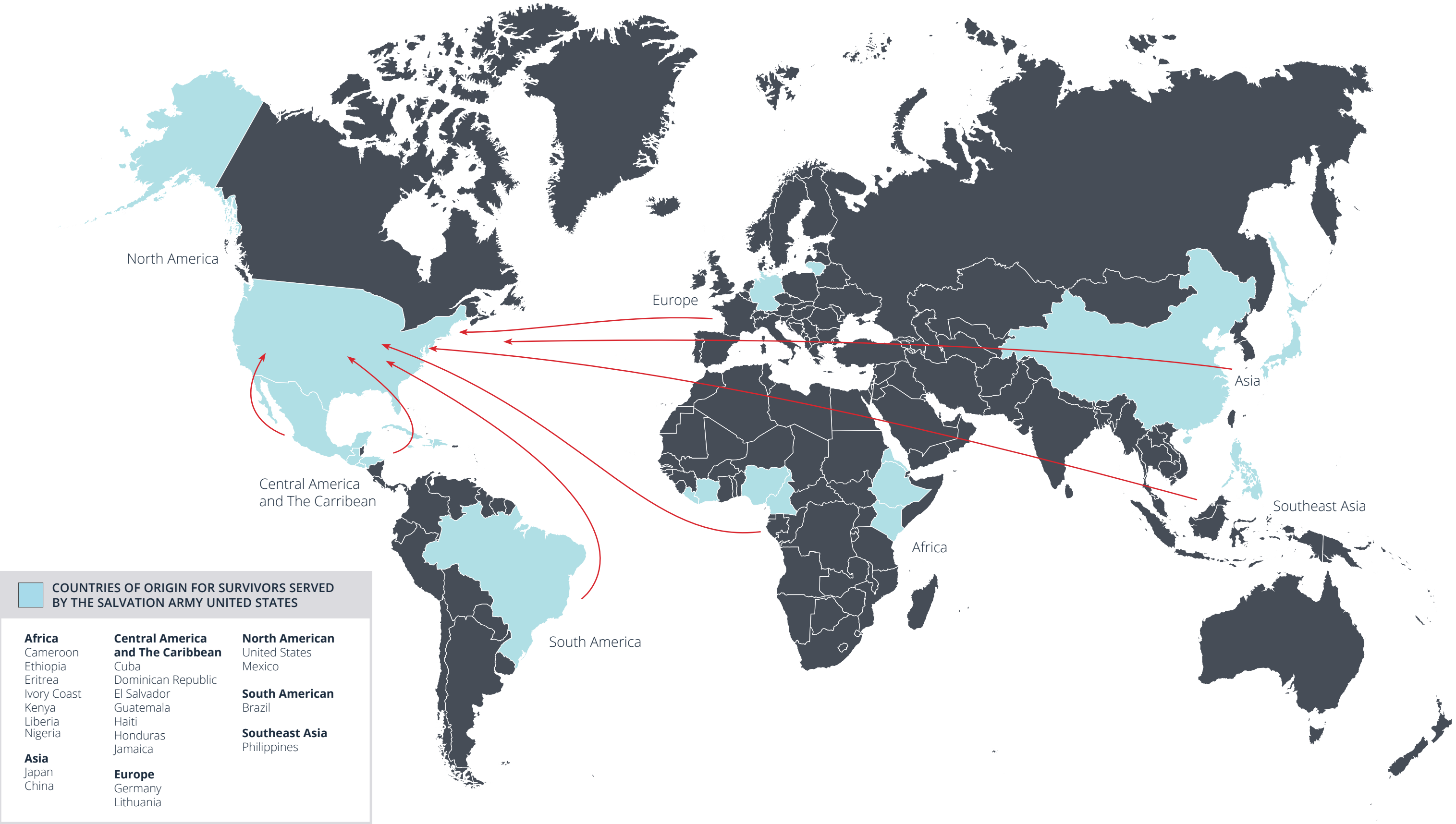
69 TASK FORCES AND COALITIONS

The Salvation Army is the lead NGO across the United States on many task forces and coalitions, working for the human rights of men, women, and children regardless of age, nationality, or gender. We serve everyone.

Global Human Trafficking Statistics

- ▶ Department of Justice (DOJ) opened more than 1,800 human trafficking investigations and convicted 439 traffickers in 2016 (*DOS-TIP Report 2017*).
- ▶ 14,897 global prosecutions of traffickers in 2016 (*DOS-TIP report 2017*).
- ▶ 66,520 global victims of trafficking identified: 17,465 of whom were labor trafficked (*DOS-TIP report 2017*).
- ▶ International Labor Organization (ILO) estimates there are 20.9 million people around the world who are enslaved today.

THE SALVATION ARMY WORLD SERVICE OFFICE (SAWSO) IS HARD AT WORK INTERNATIONALLY
IN THE FIGHT AGAINST HUMAN TRAFFICKING AND OPPRESSION

The Salvation Army World Service Office (SAWSO) is an independent 501 (c) 3 organization dedicated to improving the health, economic, and spiritual conditions of the poor throughout the world where The Salvation Army is active. Since 1977, SAWSO has helped people help themselves through sustainable programs that improve living conditions, combat the spread of disease, raise skill levels, increase productivity, and instill self-confidence.

SAWSO's Anti-human trafficking initiatives include protection, prevention and partnership building around the world. We support deported women and children as they reintegrate into Mexico. These families are extremely vulnerable to trafficking, as they land in a place where many of them haven't lived for years. In the Middle East we support a home that houses foreign-born workers, who have had their passports and visas taken. These vulnerable women are unable to travel back home and many are accused and tried for leaving the families that had entrapped them. The Salvation Army walks alongside them and helps to repatriate them to their home countries. In India we are present in some of the most vulnerable communities through our self-help groups and drop-in centers. We have started livelihood projects for women who are prostituted in red light areas and work closely with their children to ensure that the children attend school and find a livelihood after they graduate.
