

We believe, therefore, that we have the responsibility, both individually and collectively, to work for the liberation of those who have been enslaved in this manner, and to establish the legal and social mechanisms to stop human trafficking.


Highlights Across the United States of America

- Representation from each territory in The Salvation Army North American Anti-Trafficking Committee working to strengthen The Salvation Army's initiatives





Success Stories

Eastern Territory

Restoration Now, Delaware

We worked with a young woman for about 2 years, on and off, while she went back and forth, in and out of "the life." She eventually ended up being trafficked to another location about four states away. The Salvation Army program, Restoration Now, was able to get her out of that situation, and pay for transportation back to Delaware. We also collaborated with Polaris Project, the national hotline, to get her friend back to Delaware, as she too was being trafficked.

A year later, Restoration Now has helped her earn a free Certified Nurse Assistant Training and connected her with our partner who was able to secure her an apartment. Restoration Now has helped her financially in the areas of: groceries, clothing, car maintenance, etc. She is beginning her therapeutic journey, working through her trauma with a counselor, and learning to move forward and live independently. We are still in constant contact with her as we continue to support her goals.



Western Territory

Orange County, California



A Human trafficking survivor,*Tina, began receiving comprehensive services from The Salvation Army Anti-Trafficking Services (TSA-ATS) on March 21, 2022. Tina was immediately linked to legal services, working on immigration relief related to her trafficking through a T-Visa and U-Visa application with the United States Citizen & Immigration Services. ATS case managers have assisted Tina in reaching her goals through advocacy, referrals to supportive services, emotional support, creating community, and general case management. ATS case managers have provided advocacy at the Orange County Social Services Agency so that she could obtain medical insurance and other public benefits through the statefunded Trafficking and Crime Victims Assistance Program (TCVAP). These benefits allowed Tina to access mental health services and medical attention, all of which were inaccessible to her while being trafficked. Tina has also been supported in reaching her goals of going to school to learn English as a Second Language, assistance with food stamps and MediCal, and connecting her with a nearby church to help her heal through her emotional pain and trauma.

Tina has expressed gratitude towards the program and shared that if she was not connected

at The Salvation Army she would emotionally and mentally not be okay. For example, before she arrived at ATS, Tina was very depressed, felt hopeless, and she could not talk much without crying. Since arriving at the guest house the program has helped her in her healing journey, restoration and finding herself again. Tina is rehabilitating her life by taking strides to do the things she always wanted to do by going to school, therapy, church, taking cooking classes and volunteering and participating at ATS events. Tina is the definition of success - she has only been here a short time, but since this short time, she has accomplished so many goals and we know she will continue to grow upward and onward.

Central Territory

STOP-IT, Chicago

The Salvation Army STOP-IT Program provided intensive case management to a 25-year-old survivor of sex trafficking. *Christine initially contacted STOP IT in November but due to safety concerns around her trafficking situation, it was unsafe to have her case worker reach out to maintain contact. Christine was able to reconnect with her case worker in December after leaving her trafficker. Christine expressed interested in housing assistance, pro bono legal services and intensive emotional support, and with the support of her case worker and local task force partners her needs were met. Christine reported that she was still selling sex to pay bills and maintain stability. She worked closely with her case worker to create a safety plan and reduce risk of harm while working toward her goal of no longer having to sell sex.

Christine's case worker was able to refer her for an emergency housing voucher and they secured an apartment for her and her children to move in. Christine was then able to move forward onto other goals such as attending school, maintaining her health/medical needs, and finding employment. Additionally at this time, Christine was able to get connected to some trusted law enforcement partners through the taskforce collaborative relationships when initially she was too hesitant to get law enforcement involved.



Southern Territory

SIMON & First Choice, Texas

*Janie fought alcoholism for years and had been in jail for solicitation of prostitution. She was diagnosed with Post Traumatic Stress Disorder after surviving challenges during her childhood with an alcoholic caregiver, and later survived domestic violence as an adult. Sadly, she lost custody of all four of her children.

A Mental Health & Mental Retardation (MHMR) Evaluator had told her about trauma-informed care at the SIMON program while she was in jail. Janie had been sent to The Salvation Army Mabee Center from RISE courts, and received access to the wraparound services provided through all the agencies working with the courts, including an intensive outpatient program (IOP) through M.H.M.R. Tarrant's Pine Street Rehabilitation Center.

She relapsed early on but got back on track and stayed the course. She accessed supportive services through intensive case management while living in stable, safe housing at the SIMON program at Mabee Center. She started working at a restaurant while staying in the program and later became a housekeeper at a cleaning agency saving part of her income while continuing her peer support groups and individual counseling sessions.

Janie fought for stability and continues attending meetings today. After a year in the SIMON program at The Salvation Army Mabee Center in Fort Worth, she lives in an apartment and has regained custody of all four children. She has been living independently for over two years now. During a recent Salvation Army aftercare session, she smiled as we watched her making dinner for her family while sharing her successes with her peers. She is grateful to have her children back in her life and says this is her "best living."
